

**San Ignacio Vistas, Inc.
Homeowners Association
Minutes Board Meeting**

April 3, 2006

Approved By the Board May 1, 2006

Present: Board Members: Marianne Bishop, Gorman Fisher, Linda Gregory, Roger Mikusek
By phone: Bob Christensen. The meeting was called to order at 9:05 AM. There were no additions or corrections to the agenda.

1. Reading of the Minutes

The minutes of the February 6 board meeting, were revised to reflect the fact that procedures for appeal should have appeared as New Business following the agenda and the minutes were approved as corrected. The secretary then read three minor corrections to the minutes of the March 6 board meeting distributed via email and these minutes were approved as revised.

Because of poor phone reception, Bob Christensen dropped out of the meeting.

2. Officers' Reports

A. Secretary

Because the Secretary assembled the Annual Meeting Minutes booklet and readied it for mailing, the association recognized a \$223 savings.

The Secretary was given a budget not to exceed \$2000 for the preparation of the Governing Documents booklet with cover letter and the March edition of the SIV View. On March 18 a committee consisting of Gene Bengston; Barry & Marianne Bishop; Mona Brock; Dick & Sandra Matty; Roger Mikusek; and Bill & Rosemary Strube spent the morning assembling 300 booklets. Once assembled, the size and weight of the books made it evident that it would be better to hand distribute the booklets to the 200 homeowners in residence in Green Valley. Barry Bishop and Gene Bengston volunteered and accomplished this task in less than 2 weeks. The remaining books were mailed to out of state homeowners using first class at a cost of \$78. There were 300 booklets prepared at a cost of \$1700. This will give us a reserve for distribution to new homeowners if the book is not passed on at transfer.

The Secretary raised the question of scheduling the Neighborhood Garage Sale as approved by a majority of homeowners by a December 2005 survey. Since it was the consensus that the sale be held when more homeowners are in residence the sale will be advertised in the Green Valley News and scheduled for Friday and Saturday: Feb. 23-24 or Mar. 2-3, 2007. Details as to hours of the sale will be determined later.

The Secretary suggested that our HOA consider some gesture of appreciation for board and committee members for their time and effort expended on behalf of SIV functions. Without volunteers, we would have to hire and turn these duties over to a management company. The president asked that suggestions be brought to the next meeting.

B. Treasurer

The Treasurer distributed the Financial Report as of March 31, 2006. A motion was made and seconded to accept the report, subject to audit, (Attachment "A").

The budget was reviewed by line item comparing first quarter expenditures against total budgeted amounts. The Treasurer suggested that we move some money from savings into reserves. After discussion Linda made a motion, seconded by Roger Mikusek to a move \$4,000; all were in favor.

Linda suggested that Bob Christensen accompany her to AG Edwards in July when the next investment matures since Roger will not be in Green Valley.

C. President

Gorman gave a highlight of the morning session of the CAI meeting.

- HOA industry 45 yrs old; consisting of 300,000 associations
- Our documents define the type of organization
- It is important to communicate to our homeowners that they are part owners in all common areas.
- Order of governance is Federal; State; Case Law then Governing Documents (which must not conflict with the foregoing).
- What must be recorded: Plat & CC&Rs and Articles – it is not necessary to record Bylaws, Policy Statements or Rules.
- Key words in documents are MAY and SHALL
- Owners have ultimate authority
- Occasionally put financials into the Newsletters.
- Having a residents' manual or welcoming package is a good idea

Financial procedures were discussed at length and the following recommendation was made: The Secretary will deliver the bank statement to Bob to reconcile the checkbook. We might have to have a month delay in order to produce the statements, especially since the May meeting is on the first of the month.

3. **Committee Reports**

A. Maintenance Committee

Linda Gregory, acting Chair, gave the MC report (Attachment "B").

B. Architectural Committee

Gorman Fisher, acting Chair, provided the AC report (Attachment "C"). The AC approved the house on View Ridge Dr. that appeared to be painted in a non-conforming color. Gorman said it looks brighter and will rectify once faded by the sun.

C. GVCCC

Roger Mikusek presented the report (Attachment D).

4. **Continuing Business**

A. Secretary's Compensation

Roger asked that we hold a special election.

- 1) Asking for a volunteer who is willing and qualified to perform the Secretary-Treasurer function and only be reimbursed for expenses;
- 2) Hire a management company for a minimum of \$20,000/yr;
- 3) Change bylaws so that we can compensate the Secretary-Treasurer at \$_____ amount beginning _____.

No return of the ballot will assume you agree with the board's recommendation.

Roger was asked to prepare a draft ballot to be sent to the members and see if he can get some homeowners that are not on the board to work with him on this project. Marianne will work with Roger to prepare the job description to accompany the ballot.

5. New Business

Because Bob was not at the meeting, the Legislative Update portion of the CAI meeting was postponed to the May meeting.

6. Adjournment

The next meeting will be on Monday, May 1 at Canoa Rec Center in the Mesquite Room. With no further business to come before the board, the meeting was adjourned at 11:15 AM.
