The meeting was held at 1773 W Sonoran View Dr, and called to order at 9:30 AM. A quorum of the board was present: Marianne Bishop, Paul Gilmore, and Delores Leavitt.

Homeowners present: Joyce Bulau; Jim Callahan (Architectural Committee); Gary Ebbesen and Larry Engel (Maintenance Committee); Jack Powers, Audit Committee.

1. Consider/Approve Minutes

A MOTION was MADE by Paul Gilmore SECONDED and UNANIMOUSLY PASSED approving the minutes of the January 11, 2011 meetings as distributed.

2. Audit Report

A MOTION was MADE by Delores Leavitt SECONDED and UNANIMOUSLY PASSED accepting the Audit Committee Report and the Audit Letter dated January 24, 2011 and commending the Audit Committee for its excellent work on behalf of the Association.

The Audit Committee report and letter will be presented to Homeowners and made a part of the minutes of the 2011 Annual Meeting.

For internal control purposes, following the Annual Meeting and election of new officers, the board will obtain read-only access for all of the bank accounts so that the 1st vice president can review all monthly activity.

Once the Financial Advisory Committee membership is confirmed for 2011 a meeting will be called to update the earnings assumptions underlying the Plan and make other modifications as deemed necessary. As part of this process, the Audit committee suggests a re-evaluation of the Association's investment policies. In addition, it was proposed that the chair of this committee not be a board member.

3. Treasurer's Report

A MOTION was MADE by Paul Gilmore SECONDED and unanimously PASSED approving the Treasurer's Report, ending 1/31/11 subject to Audit (Attachment A).

All dues for 2011 have been paid.

Ed Eick canceled the financial advisory committee meeting called for January 27. The 2011 transfer to reserves has not been made and the Treasurer is awaiting direction from the Board after the reconstituted committee meets.

We are waiting for the following tax refunds:

- 1) \$2,328 from the State of Arizona for tax years 2006, 7 and 8 and
- 2) \$1,600 estimated tax paid to the IRS for 2009.

4. OFFICER'S REPORTS

A. President

Effective January 29 Ed Eick resigned from the board and all committees.

B. Secretary

The Secretary will call a meeting of the Financial Advisory Committee to review and update the current long-range plan. We will also investigate the pros and cons of moving our checking account from BBVA Compass to the Commerce Bank of Arizona.

About 150 ballots have been received thus far and all ballots received by February 17 will be turned over to the tellers. The count will take place on Friday, Feb 18, 2011

The Maintenance Committee verified that the homeowner at lot 126 was very cooperative in clearing all debris behind their lot. The violation was removed from the record.
